

## MINUTES OF BURNHAM MARKET PARISH COUNCIL MEETING

held on Monday, 20<sup>th</sup> of February 2023 at 6:30pm at Burnham Market & Norton Village Hall, Beacon Hill Road, Burnham Market, PE31 8EN.

1. Welcome from the Chairman.

Apologies and consideration of acceptance for absence. Cllrs Morris – family illness, Sandell & Jamieson – work commitments

- 2. Member's declarations of interest and requests for dispensations: None
- 3. Public Speaking:
  - a. Re planning application 23/00103/F 2 new dwellings, Overy Road Nurseries. One of the applicants advised that the application was for a local family who have been in the village for many years and the dwellings were for the 2 children to ensure they could continue to live and work in the village. The look of the area would be much improved.
  - b. A second applicant of the above application gave their views on the AONB aspect along with Norfolk Coastal having no issues wit the application. They do realise it is just outside the boundary, but it is for the family use and not developers.
- 4. The minutes of the Full Council Meeting held on the 13<sup>th</sup> of December and the extraordinary meeting on the 8<sup>th</sup> of December 2022 were agreed as a true and correct record Proposed Cllr Borlace, seconded Cllr Clerk and all in favour who were present at the meetings.
- 5. Matters arising from the last meeting:

5.1 Craft Fair and Car Parking – the date of the 19<sup>th</sup> of August was approved and confirmation that the Parish Council would provide the car parking was made.

5.2 Defibrillator training – the clerk advised that training had been found for groups up to 12 at a time and it was hoped that this would take place in April in the Village Hall. Anyone who would like to join the training, please contact the clerk directly.

5.3 Highways site visit – the chairman covered all the points raised during the site visit and further updates to follow in the March meeting including siting and type of commemorative tree, quotes/funding for a trod, tidy the area around the pond can start now including the removal of the seeded trees. It was a no for the tidying of the village entrance on the Docking Road, but we were asked to review double yellow lines, and this will include the traders comments. The pavement on Mill Green has collapsed and it was agreed to have a replacement footway plus the graffiti removal.

Cllr Bingley advised that it should be more central and include the history / heritage of the village and provide useful information for residents and visitors. Cllr Bingley also advised that she was working on a farmers style market on a monthly basis starting in April at the Westgate Church and any support would be most welcome.
